

CALL FOR APPLICATIONS FOR TWO IMPACT MALARIA PROJECT DRIVER POSITIONS AT ACMS

Background and rationale

PSI (Population Services International) and its local affiliates manage malaria control programs in 32 countries and are world leaders in malaria control implementation with 42 million treated mosquito nets distributed and about 19 million quality ACTs delivered for confirmed malaria cases in 2016. PSI also provides supports to national Ministries of Health in order to scale up malaria diagnosis, especially in the private sector, and to improve tracking of malaria patients through health surveillance and information systems, notably the DHIS2 (District Health Information System).

The Cameroon Association for Social Marketing (ACMS), affiliated to PSI is seeking to recruit two experienced, dynamic and results-driven **Drivers** to drive the Project team and thus, participate in carrying out field activities related to the execution of the USAID/PMI funded IMPACT MALARIA project, which is making progress in malaria control service delivery.

Duties and responsibilities

Under the supervision of the "Program Manager", the selected Drivers will have the following main responsibilities:

- Drive the Impact Malaria Project vehicles in urban and rural areas within the framework of organized missions;
- Carry out a periodic inspection and diagnosis of the vehicle placed at your disposal;
- Carry out repairs for basic vehicle breakdowns;
- Monitor repair of the vehicle entrusted to an authorized garage;
- Keep and update a daily vehicle maintenance log book;
- Carefully manage the fuel put at your disposal;
- Fill out a refueling form in an orderly manner;
- Prepare mission reports and monthly reports;
- Perform any other task assigned by to you by hierarchy.

Qualifications and professional experience required

- Be at least 25 years old;
- Hold a **GCE O-Level or BEPC**;
- Hold at least a **category B driving license**;
- Have at least **3 (three) years of relevant professional experience**;
- Experience working with NGOs as a Driver would be an asset;
